#### 1 BENCHMARKING APPLICATION

Initial application (benchmarking scope GLOBALG.A.P. standards) <sup>1, 2</sup>	First product category within a scope	€5,500
Initial application (benchmarking scope GLOBALG.A.P. add-on) <sup>1</sup>	First add-on without Integrated Farm Assurance (IFA)	€4,500
Product category extension <sup>1</sup>	Each product category within the same scope or each add-on in addition to the first product category	€1,500
Additional year <sup>1</sup>	Each additional year of the application process (in case the benchmarking process takes longer than 12 months)	€1,000
In-house trainer (IHT) training <sup>3</sup>	Each scope or add-on (before each benchmarking application for Option 3)	€500

<sup>1</sup>The application covers the application process for one year, incl. on-site assessments and the review of documents according to the GLOBALG.A.P. benchmarking regulations version 6 and its subsequent updates, until further notice.

<sup>2</sup>An application for a new IFA scope or GLOBALG.A.P. standard is considered an initial application and the initial application fee shall apply.

<sup>3</sup>Mandatory for the person responsible for filling out the benchmarking cross-reference checklists. Additional fee applicable for quality management system (QMS) IHT training for benchmarking applications submitted for Option 4 producer groups.

Benchmarking scope GLOBALG.A.P. standards	Fees apply per product category and service provided to the BCSO in accordance with the benchmarked scheme according to the <u>GLOBALG.A.P.</u> <u>system participation fees</u> .
Benchmarking scope GLOBALG.A.P. add-ons	Fees apply according to the <u>GLOBALG.A.P. system participation fees</u> .

<sup>5</sup>*Annual fee* for each producer registered in the GLOBALG.A.P. IT systems for a benchmarked scheme (Option 3 and Option 4) based on production units (area, metric tons, employees). Charged to BCSOs or to the approved BCSO certification bodies (CBs).
